**ADDENDUM N° 02**

TO THE MEMORANDUM OF UNDERSTANDING BETWEEN THE EMBASSY OF THE UNITED STATES OF AMERICA IN PARAGUAY AND THE MINISTRY OF ECONOMY AND FINANCE OF PARAGUAY ON BEHALF OF THE NATIONAL POSTGRADUATE SCHOLARSHIP PROGRAM "DON CARLOS ANTONIO LOPEZ" REGARDING EDUCATIONAL ACTIVITIES AND INSTITUTIONAL SCHOLARSHIPS [Hereinafter referred to as the 'MOU']

On the one hand, THE UNITED STATES EMBASSY, represented by LEANNE CANNON, Public Affairs Officer with address at Mcal. Lopez 1776 of the city of Asuncion and on the other hand the MINISTRY OF ECONOMY AND FINANCE of Paraguay, represented in this act by ANDREA MERCEDES PICASO, Vice Minister of Human Capital and Organizational Management, appointed by Decree No. 191 of August 30, 2023, and, ALEJANDRA BOGADO TERVIT, Director General of the General Directorate of Training for Development, appointed by Resolution M.E.F. No. 31/2024 with address at 252 Chile St. between Palma and Pte. Franco of the city of Asunción, hereinafter the Parties, agree to sign this Addendum No. 02 to the Memorandum of Understanding between the Parties, following the following clauses:

**FIRST: PURPOSE.**

The purpose of this Addendum is to modify numeral 1 of Section 10 of the MOU, signed in 2020 by representatives of the National Postgraduate Scholarship Program "Don Carlos Antonio Lopez", the Ministry of Finance -nowadays Ministry of Economy and Finance- and the Embassy of the United States of America in Paraguay, so that the text will be worded as follows:

**1. SECTION 10.1 of PAGE 3:**

1. The participants intend that the MOU shall become effective as of the date of its execution and, shall remain in effect until either participant wishes to terminate the agreed relationship, per the established mechanisms.

**SECOND: SPECIAL AGREEMENTS.**

The other sections and conditions established in the MOU, signed on January 23, 2020, between the Parties, remain in force in all the terms that have not been extended or modified by this Addendum No. 02.

In proof of conformity and acceptance, the parties hereto sign this Addendum in Spanish and English being of the same tenor and to the same effect, in August 2024, in the city of Asuncion, capital of the Republic of Paraguay.
