

AMENDMENT ONE

To the Agreement for cooperation between The University of Bath of The United Kingdom and Coordination of the National Scholarship Program Carlos Antonio López (BECAL) of the Ministry of Economy and Finance of the Republic of Paraguay.

THIS AMENDMENT NUMBER ONE (“Amendment 1”), effective as of the signature date, to the Agreement signed in 2017 (the «Effective Date»), The University of Bath of The United Kingdom (hereafter «UB») with a place of business at Claverton Down, Bath, BA2 2AY, United Kingdom and the Coordination of the National Scholarship Program Carlos Antonio López of the Republic of Paraguay (hereinafter «BECAL») with a place of business at Chile St. 252, Asuncion, Paraguay.

The Agreement is hereby amended as follows:

1. Page 2, Clause 8 is deleted and replaced as follows: Each institution will designate a named coordinator to implement and monitor the program. The named coordinators are:

Page 2, clause 9 is deleted and replaced as follows: The term of this agreement shall commence on the date it was signed in 2017 and shall automatically terminate on **July 1st, 2028** unless extended or terminated sooner under the terms of this agreement. This Agreement may be terminated by either party giving written notice of intent to terminate provided not less than thirty (30) days. If termination is pursued by either party, it shall be executed such that current or admitted students are funded through the duration of their program.

Except as described herein, the Agreement has not been otherwise amended and remains in full force and effect.
